### General Information

1. Entries are limited to three (3) per person (must be different categories). Exhibits will be judged on originality, creativity and appearance. **All entries must be completely finished.**
2. Miniature Competition highlights creative talent from members and non-members.
3. Open to anyone over the age of 18. No prerequisite for entry. Please read all rules and regulations before entering.

### Entries

1. Each work will be screened before acceptance
  - a. Work must be by the exhibiting artist
  - b. Exhibits previously entered into competition at the Lakeland Miniature Show are excluded from entry again.
  - c. Work must have been completed during the past two (2) years.
2. Entry Fee: \$3.00 per entry. Send check or money order. (No cash or credit cards, please)
3. Enter by printing the attached form and send it completed with your fee to:

**Entry Form Deadline: June 15, 2018. You must complete the entire entry form.**

**One form per item entered.**

4. All entries must be delivered to the Lakeland Miniature Guild at the Hilton Garden Inn.
5. **Delivery date and times: Saturday, June 23, 2018** between 10:00 AM and 4:00 PM. Delivery and/or payment after the deadline will not be accepted.
6. Final results will be revealed Sunday, June 24, 2018.

### Design

The Lakeland Miniature Guild assumes total design control over the presentation of the exhibits. No exhibit changes will be made once the entries have been displayed. Relocation and final placement shall be accomplished by Lakeland Miniature Guild personnel. All parts must be secured by the exhibitor before delivery of item. If the exhibitor wants the Judges to look the entire exhibit, a turntable **MUST** be attached.

### Judging

A panel of judges will be selected from the Vendors. The following awards are determined based on individual merit:

- Best of Show - LMG Ribbon and \$25\*
- First Place - LMG Ribbon and \$10\*
- Second Place - LMG Ribbon and \$5\*
- Third Place - LMG Ribbon

The decision of the judges is final.

*\*Prize Money is in the form of "Show Money" to be spent at any dealer table (same as cash) during show hours.*

*Prize money will be available at 10:00 AM on Sunday.*

**Exhibit Integrity** — It is the responsibility of all members to report exhibit discrepancies before the judging takes place. Such reports must be submitted only to the Show Chairman.

### Removal of Artwork

Exhibits may not be removed until 4:00 PM on Sunday, June 24, 2018.

**The Lakeland Miniature Guild shall not be responsible for accidents or losses that may occur to any of the projects at the show and the exhibitors shall hold the Lakeland Miniature Guild and its officers harmless and indemnify them against any legal proceedings arising from such accident or loss.**
